## I. Objectives

This survey was designed to assist the World Bank Group (WBG) in gaining a better understanding of how stakeholders in Cambodia perceive the WBG. The survey explored:

- *Overall Context*
- *Overall Attitudes toward the World Bank Group*
- *World Bank Group's Work and Engagement on the Ground*
- *World Bank Group's Support in Development Areas*
- *World Bank Group's Knowledge Work and Activities*
- *The Future Role of the World Bank Group in Cambodia*
- *Communication and Information Sharing*
- *Background Information*

## II. Methodology

From January to February 2021, 333 stakeholders of the WBG in Cambodia were invited to provide their opinions on the WBG's work in the country by participating in a Country Opinion Survey. Participants were drawn from the Office of the Prime Minister; office of a minister; office of a parliamentarian; ministries/ministerial departments/implementation agencies; Project Management Units (PMUs) overseeing implementation of WBG projects; consultants/contractors working on WBG-supported projects/programs; local governments; independent government institutions; the judicial system; state-owned enterprises; bilateral and multilateral agencies; private sector organizations; the financial sector/private banks; private foundations; NGOs and community based organizations; trade unions; faith-based groups; youth groups; academia/research institutes/think tanks; the media; and other organizations.

A total of 147 stakeholders participated in the survey (44% response rate). Respondents received the questionnaire via a courier and returned it accordingly, or they completed the questionnaire online.

Every country that engages in the Country Opinion Survey (COS) must include specific indicator questions that will be aggregated for the World Bank Group's annual Corporate Scorecard. These questions are identified throughout the survey report.

The results in this year's Country Survey were compared to those in the Country Survey conducted in FY'18 (response rate was 35%, N=139). Data were weighted to reach the same stakeholder composition in two years, which allows for year comparisons. Stakeholder groups which were not present in both fiscal years were not included in the comparison. Respondents who belonged to the "other" stakeholder category were not included either. As a result, mean ratings, percentages of respondents, and the total number of respondents in both years are slightly different from those of the original data reported in the FY'18 COS report and the non-weighted data presented in appendices A, B, C and E. For the weighted stakeholder breakdown and year comparison results, please refer to Appendix D (page 80).

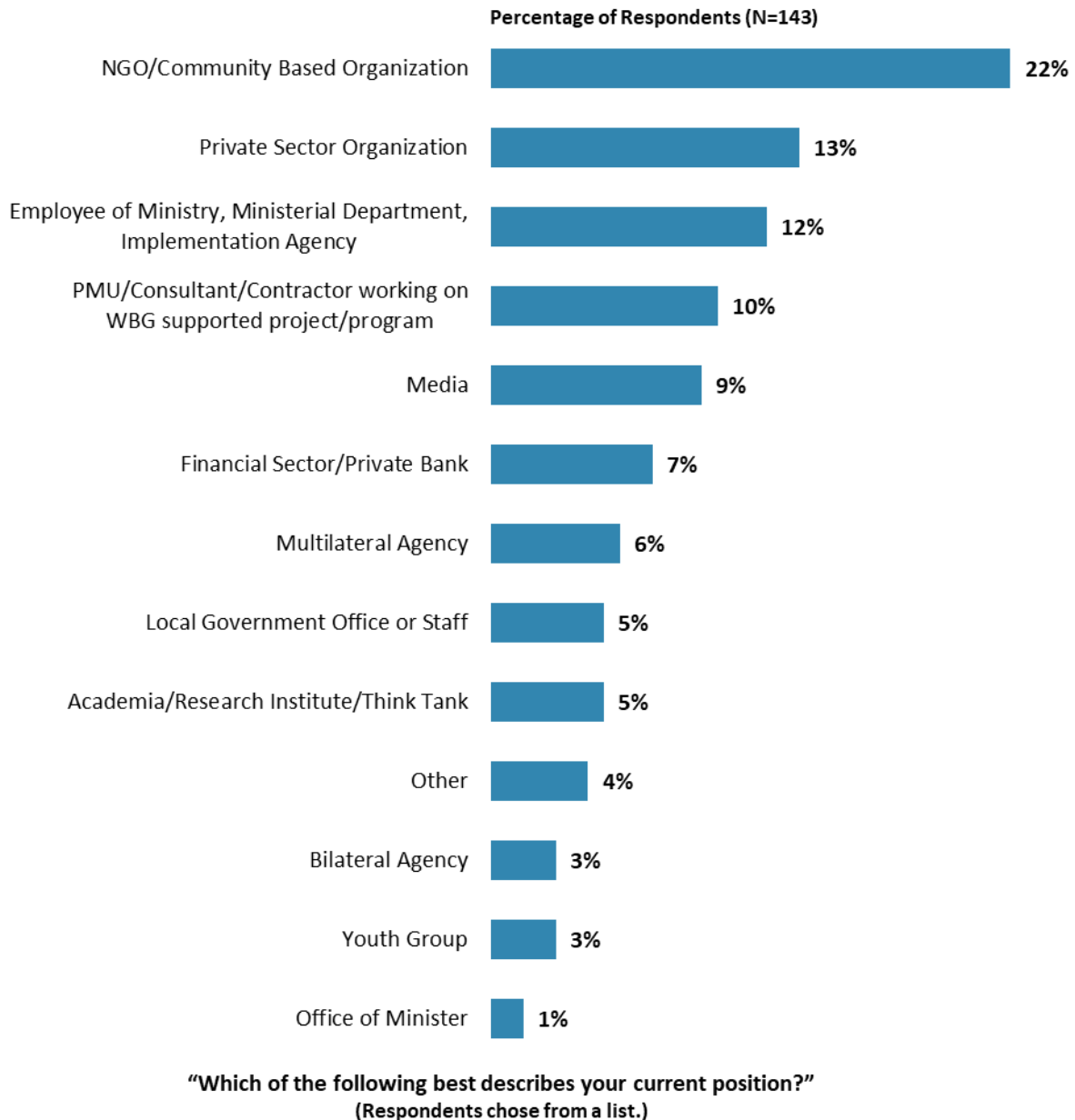

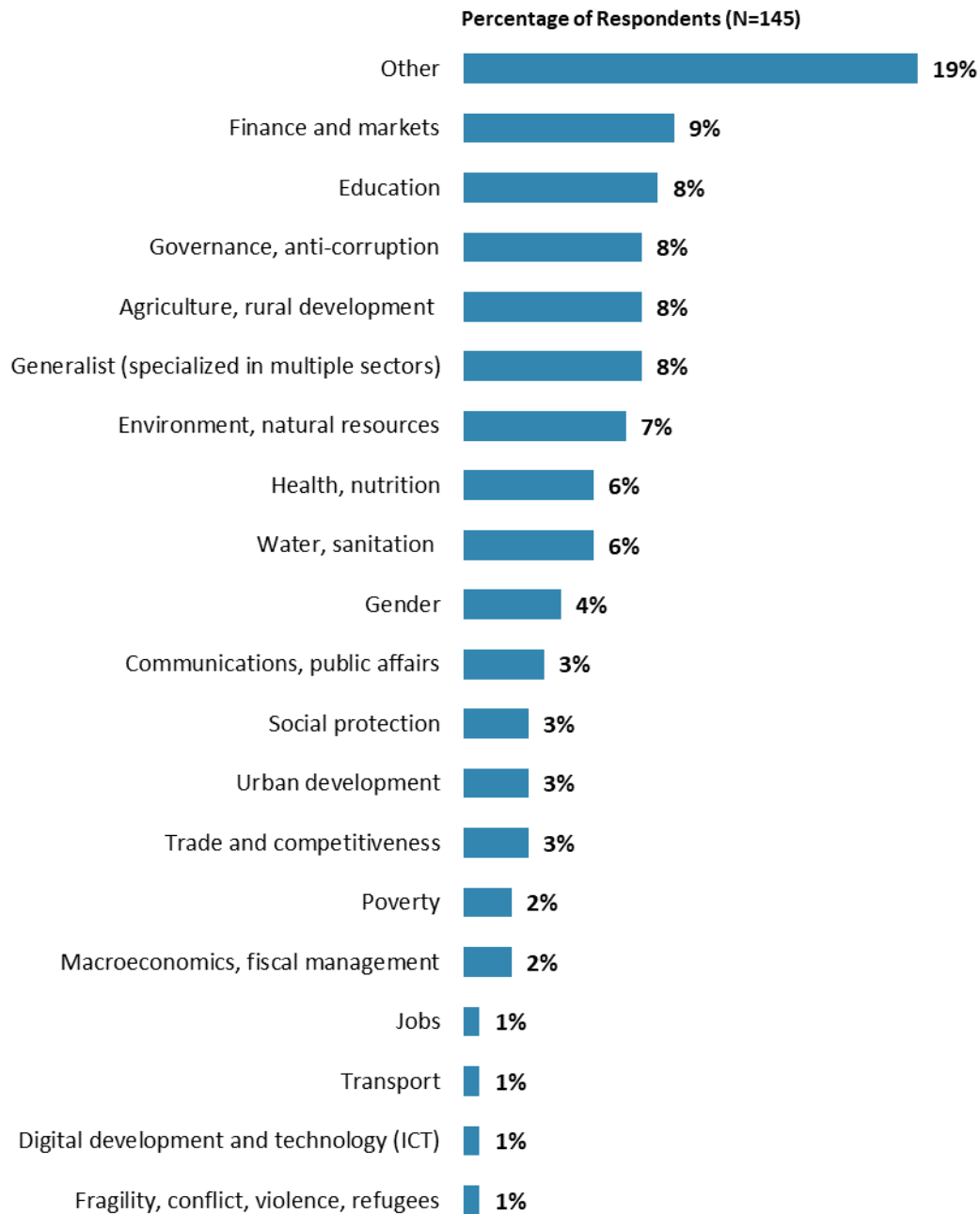

#### Area of Primary Specialization

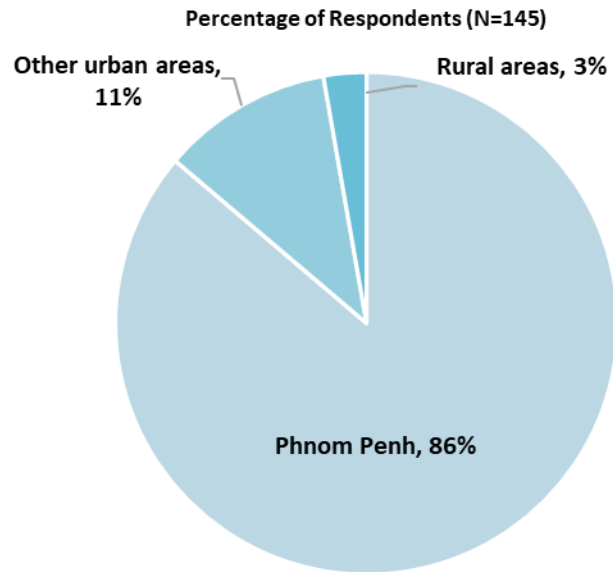

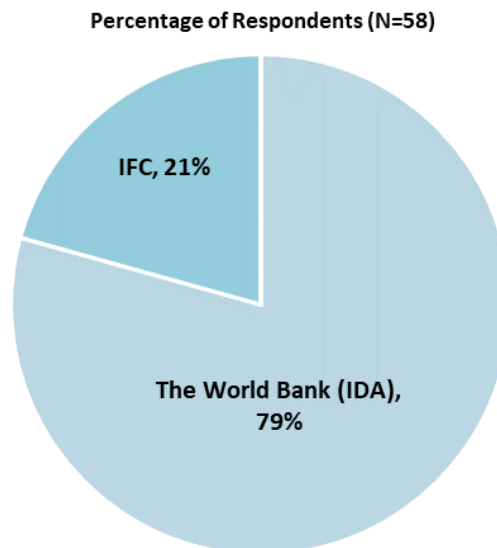
#### Geographic Locations

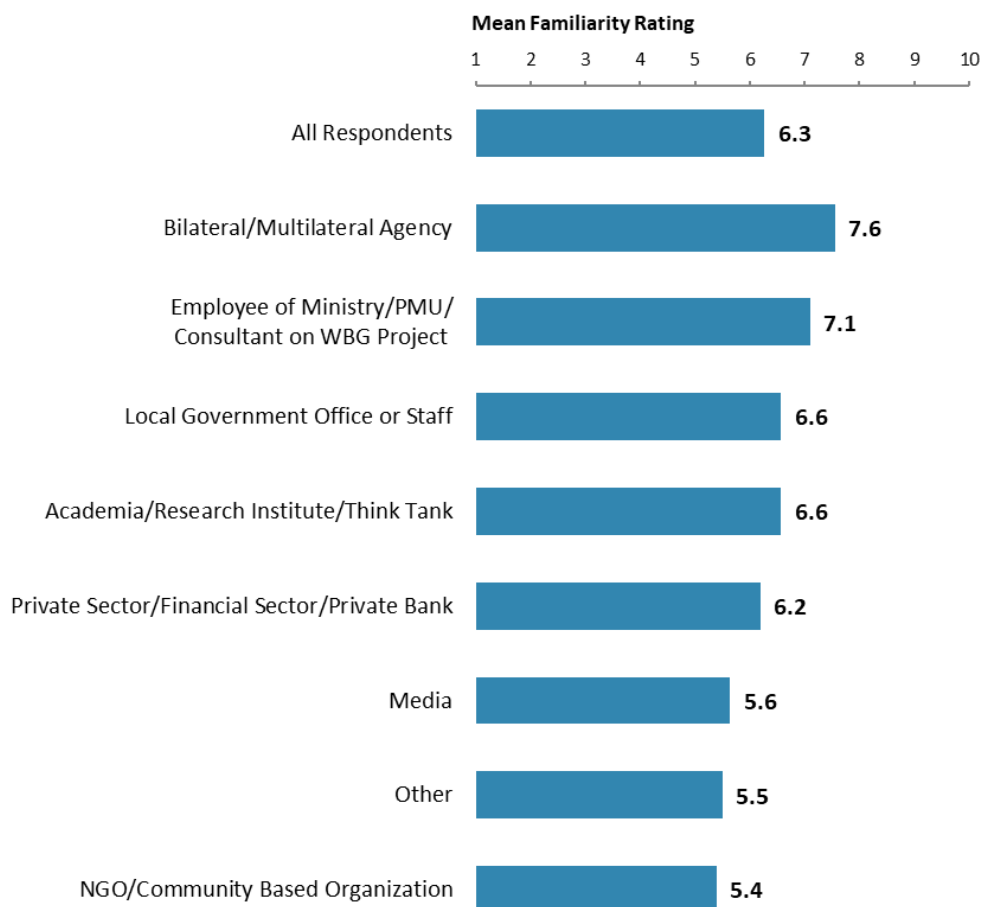

### III. Demographics of the Sample (continued)

#### Familiarity with the World Bank Group

- **Year comparison:** Respondents in this year's Country Survey had statistically similar levels of familiarity with the WBG compared to respondents in the FY'18 Country Survey (weighted mean in FY'21 = 6.3<sup>2</sup>; weighted mean in FY'18 = 5.9)<sup>3</sup>.
- **Impact of familiarity:** Respondents' ratings of familiarity with the WBG were significantly, strongly correlated with their ratings for the WBG's overall effectiveness<sup>4</sup> in Cambodia, and significantly, moderately correlated with their agreement that the WBG plays a relevant role in Cambodia's development and with their ratings of the extent to which the WBG's work helps achieve development results in Cambodia.

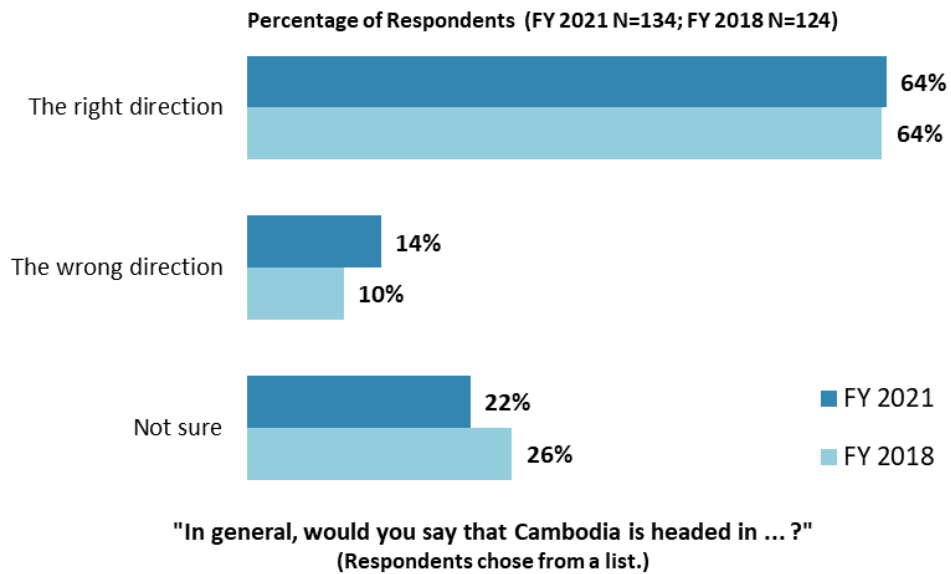

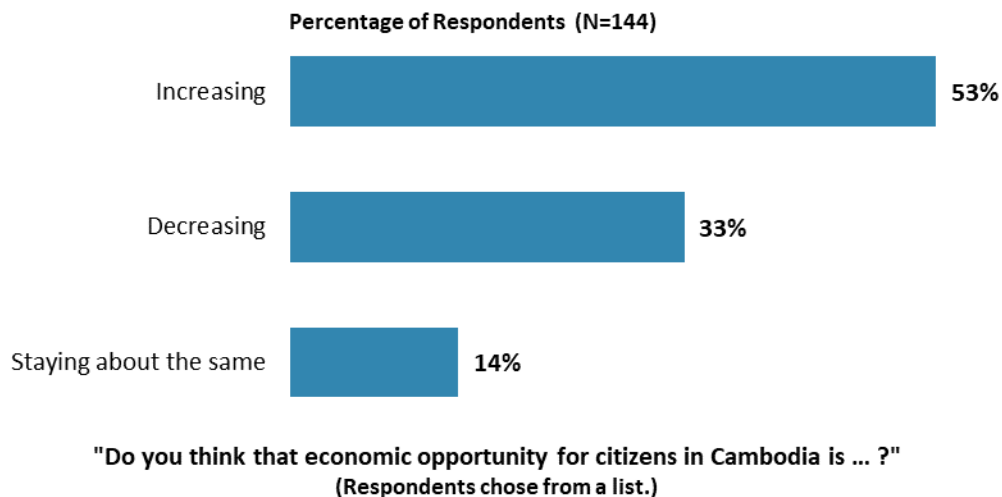

### Perceptions of Economic Opportunity



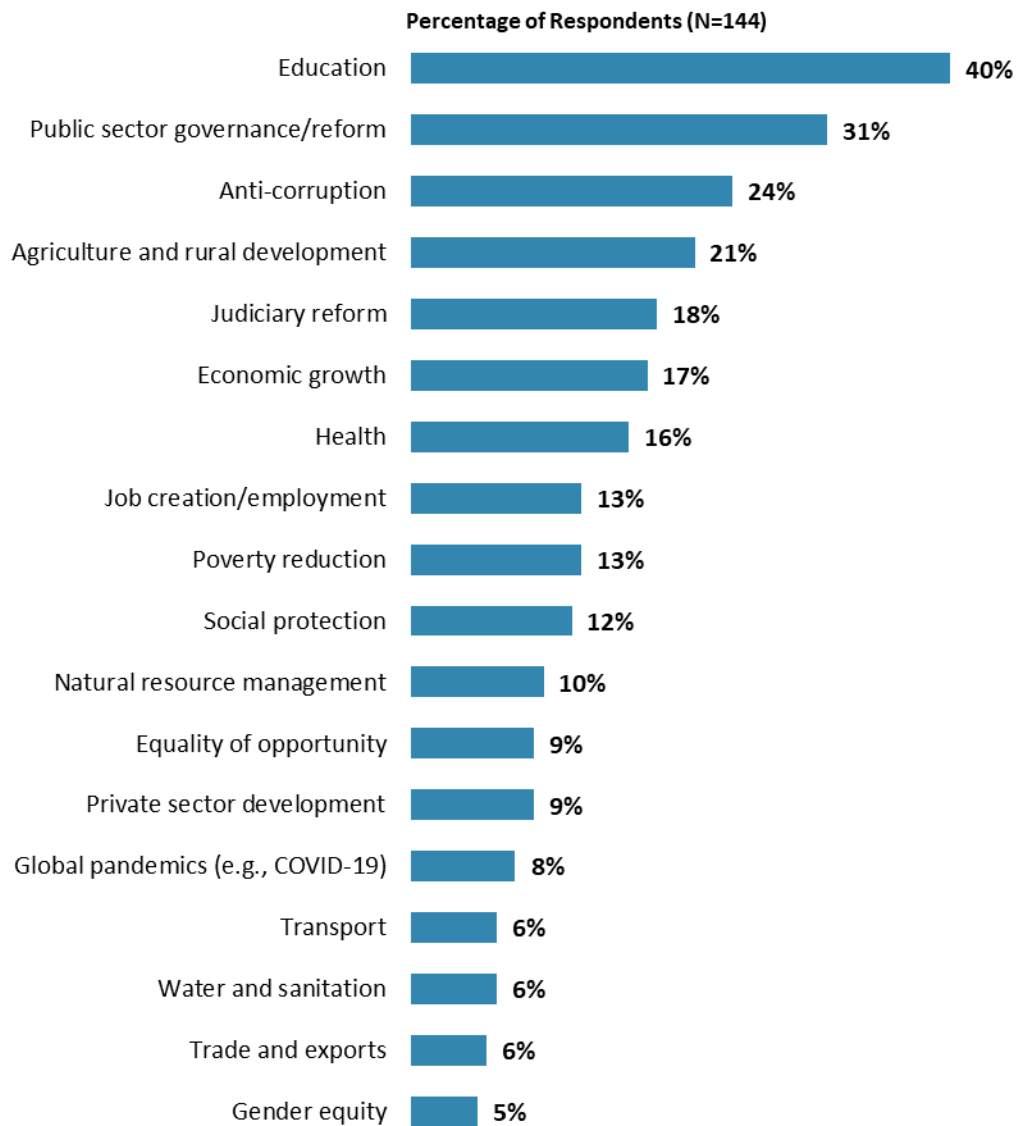

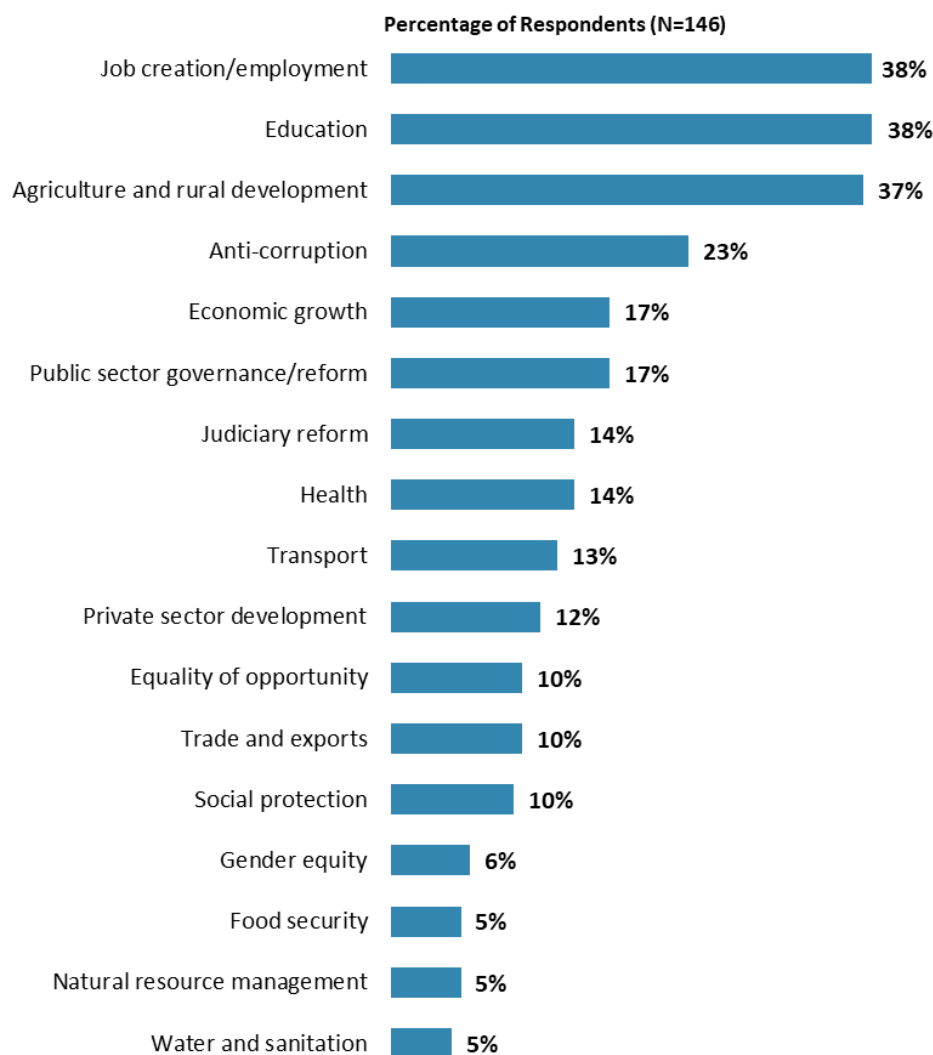

- **Year comparison:** Respondents in the previous FY'18 Country Survey indicated that the biggest contributors to poverty reduction in Cambodia were “*skills development*” (32%), “*education*” (31%), “*job creation/employment*” (29%), “*agriculture modernization and rural development*” (28%), “*anti-corruption*” (26%), and “*public sector governance/reform*” (24%).

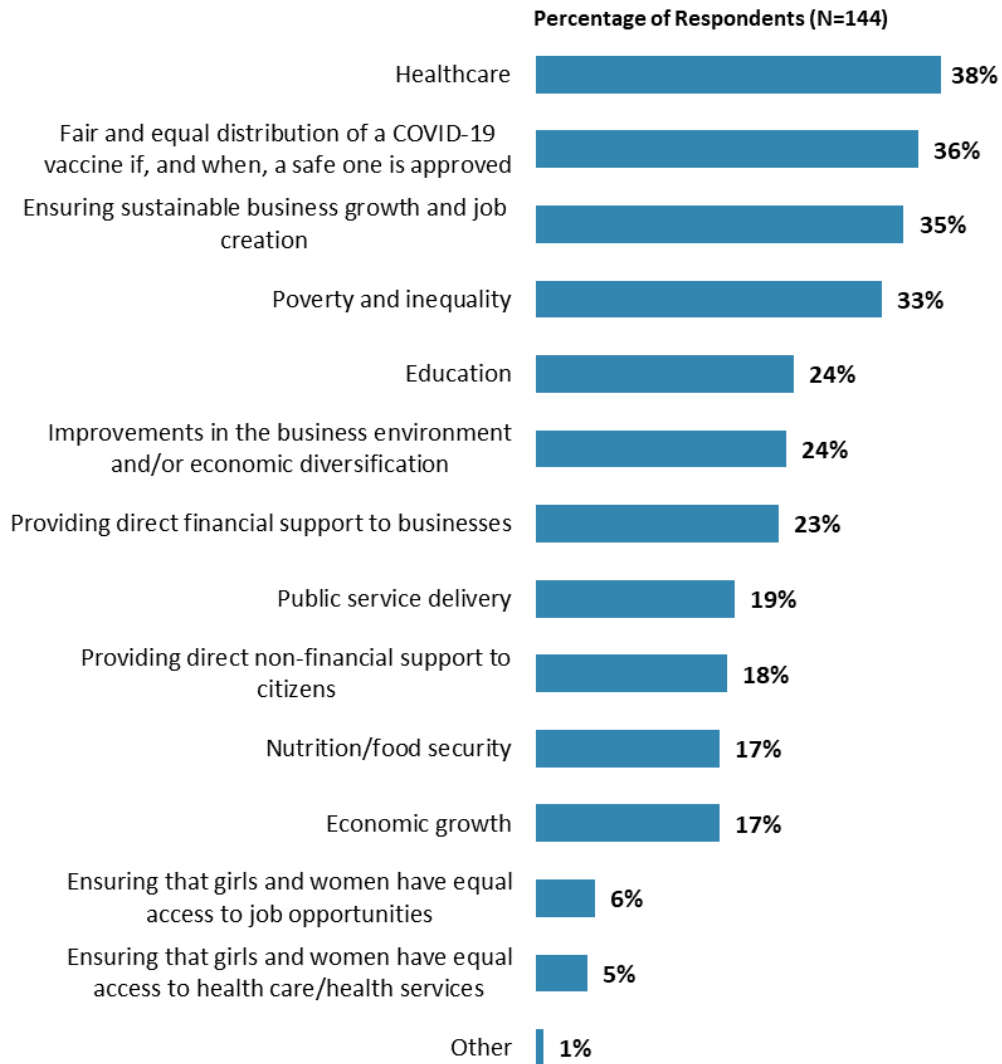

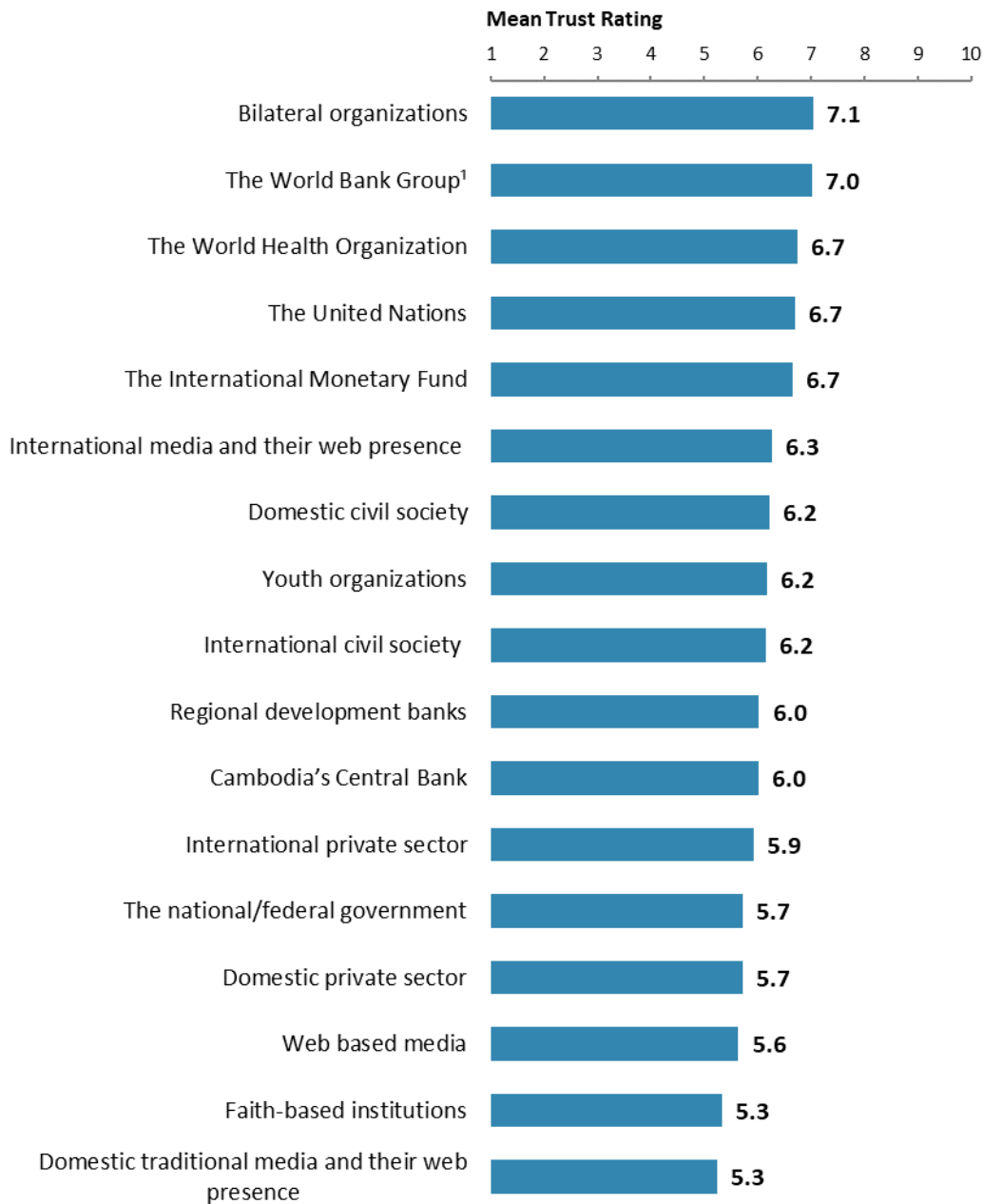

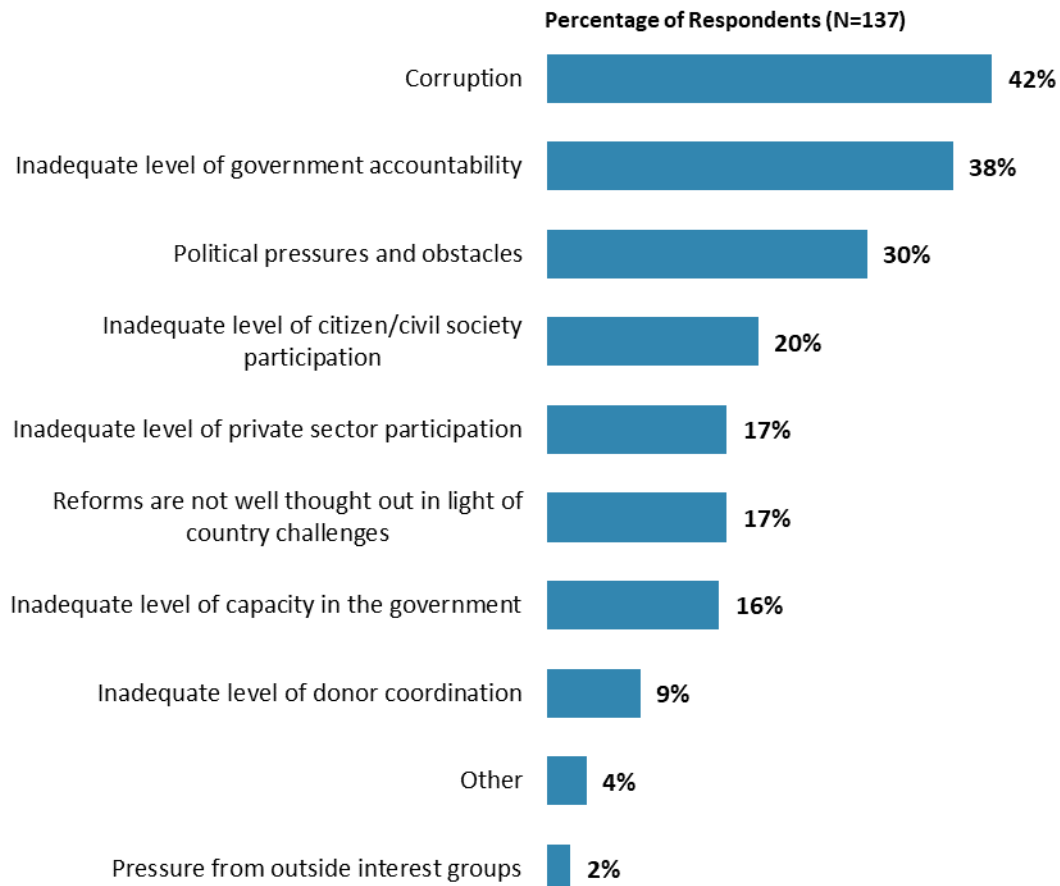

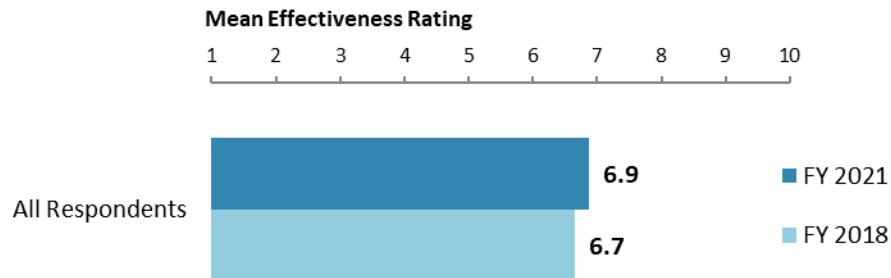


**"When economic and/or social reform efforts fail or are slow to take place in Cambodia, which of the following would you attribute this to? (Choose no more than TWO)"**

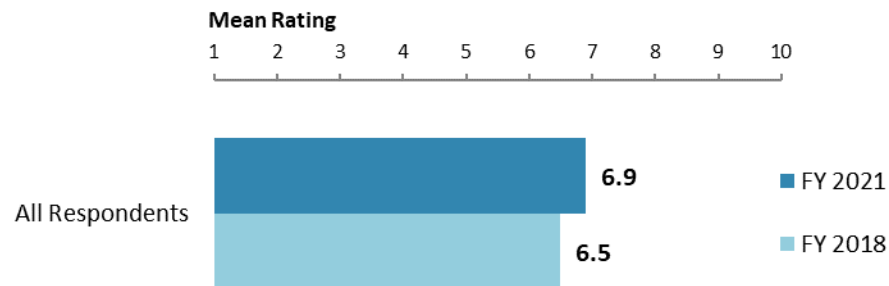

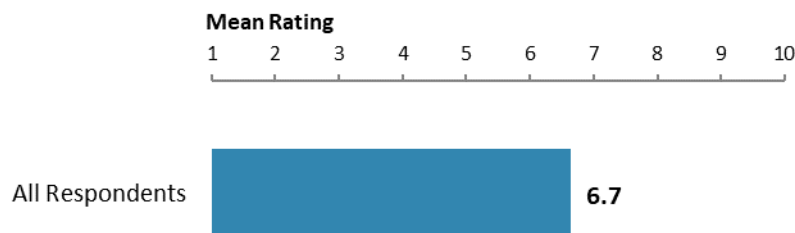

### Influence on Cambodia's Development Agenda (*Indicator Question*)



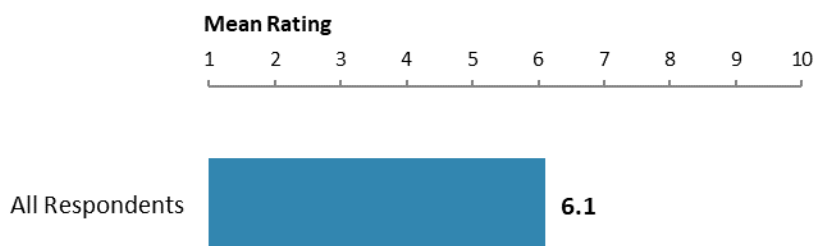

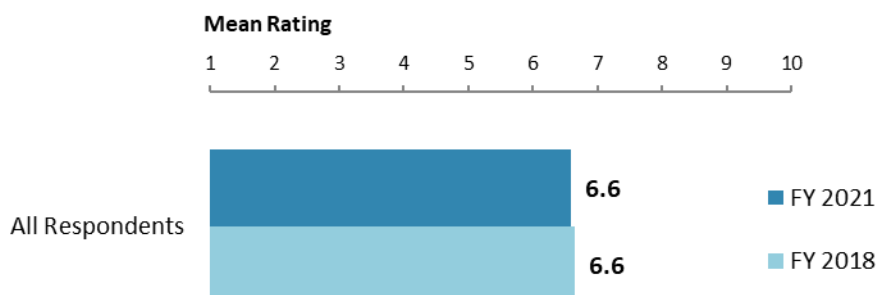

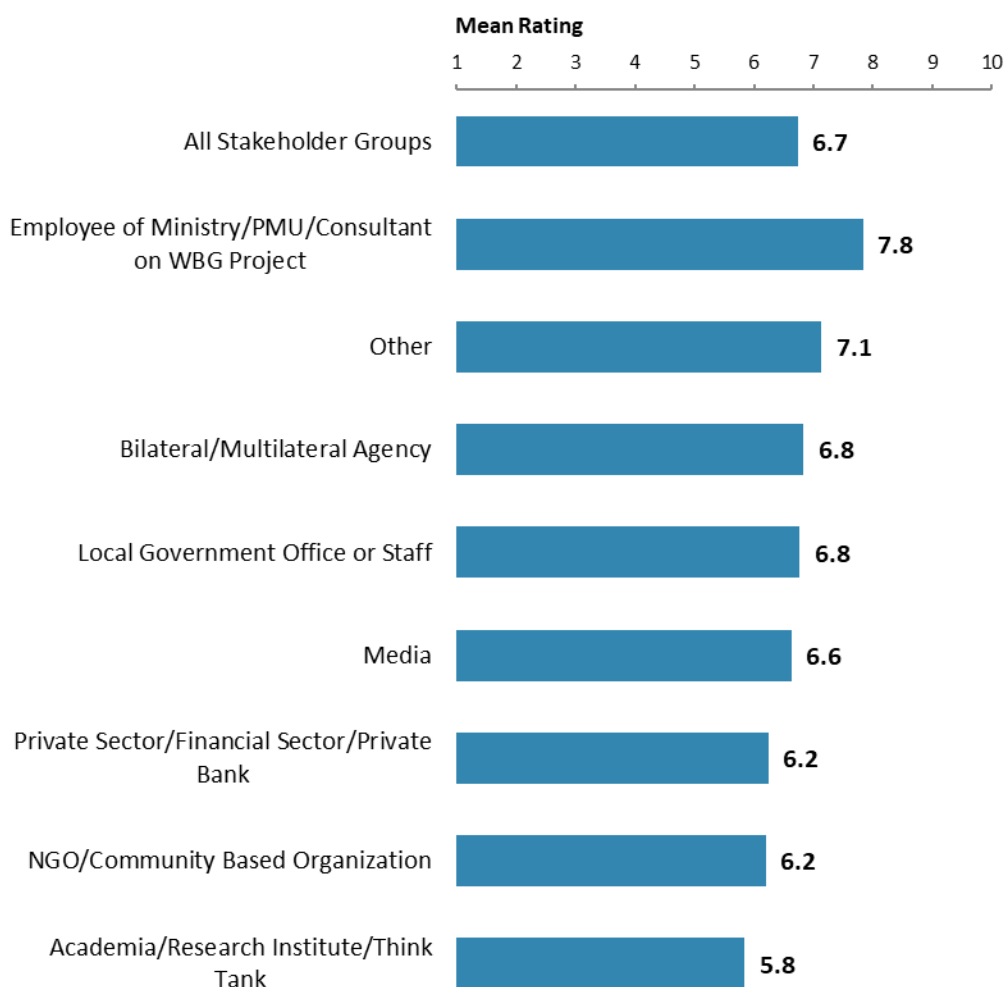

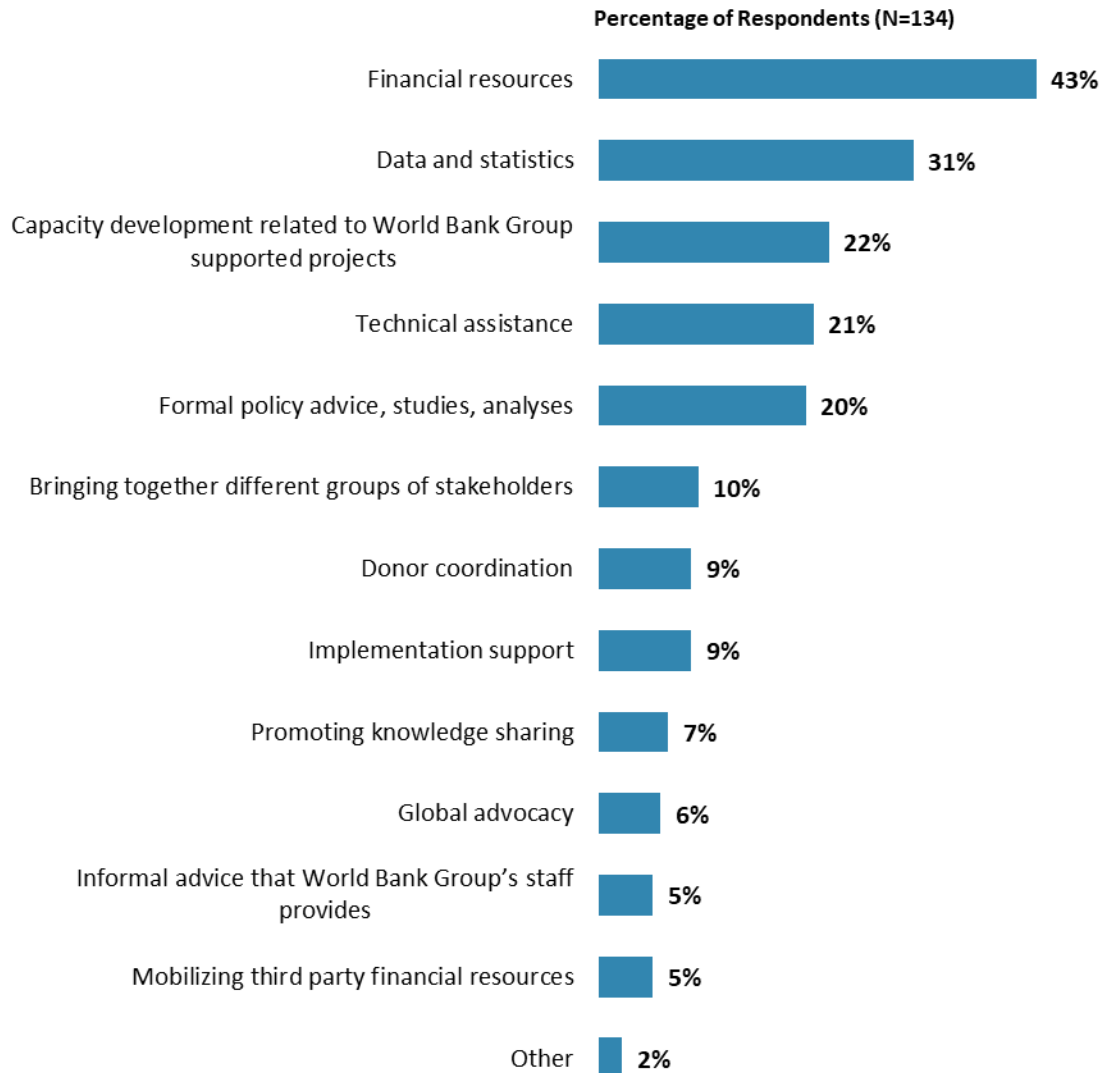
Mean Ratings for All Indicator Questions by Stakeholder Groups on a Scale from 1 to 10

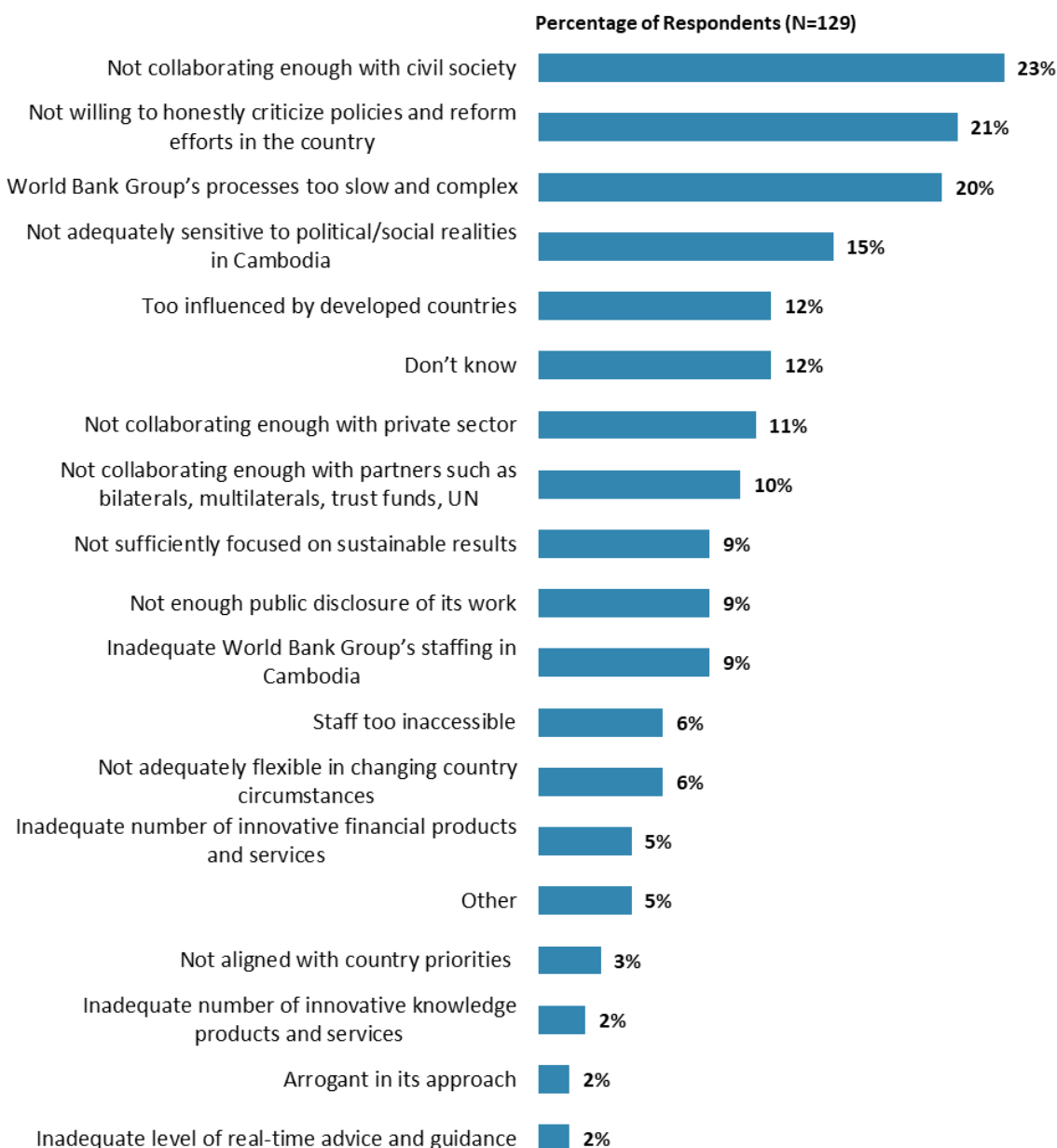
**"When thinking about the World Bank Group's role in Cambodia, which activity do you VALUE the most? (Choose no more than TWO)"**

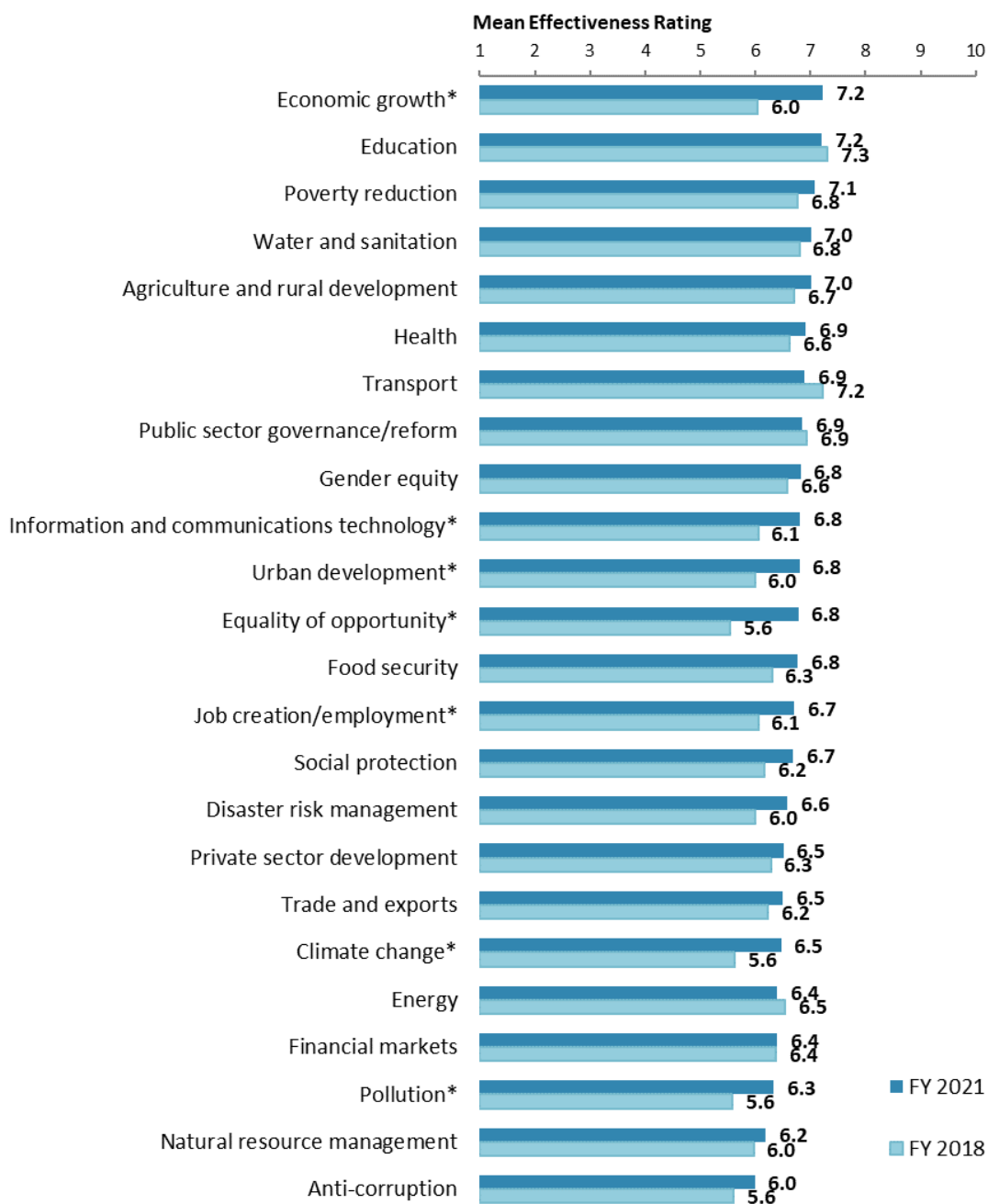


**"Which of the following do you identify as the World Bank Group's greatest WEAKNESSES in its work in Cambodia? (Choose no more than TWO)"**

### Effectiveness of WBG's Support in Sectoral Areas: Year Comparison<sup>8</sup>



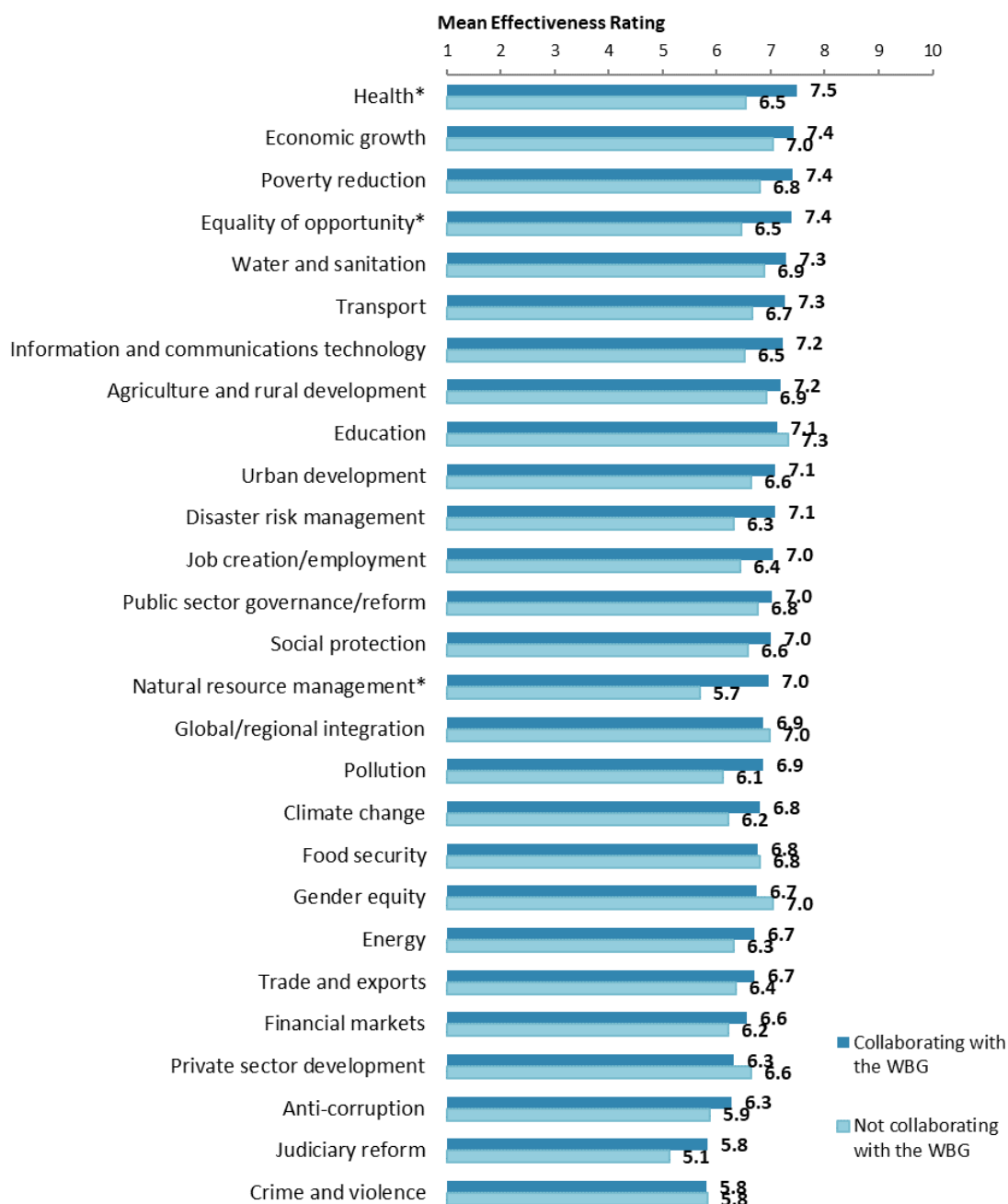

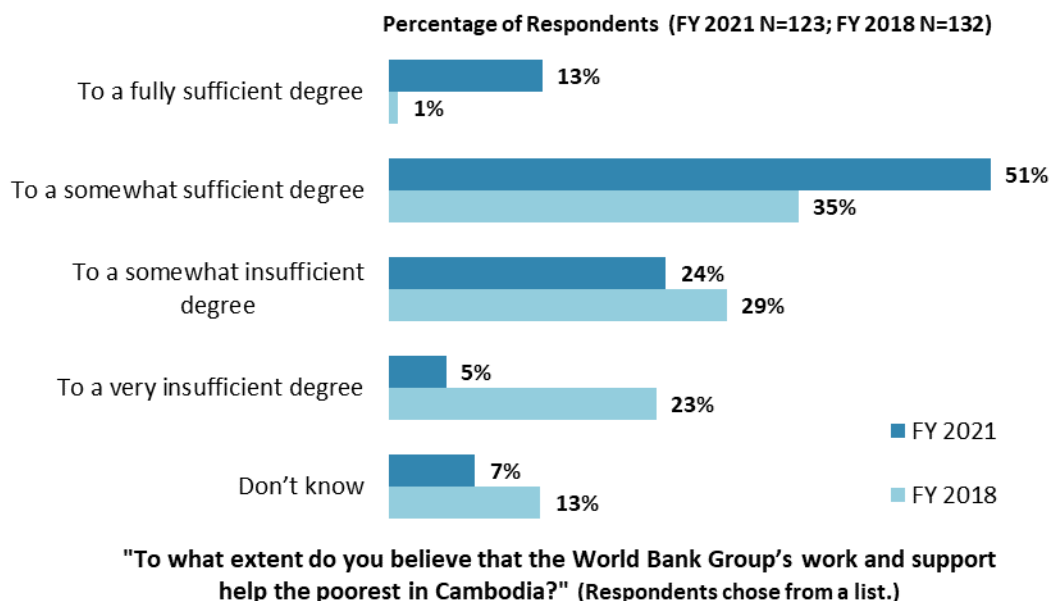
**"How EFFECTIVE do you believe the World Bank Group is in terms of the work it does in the following areas of development in Cambodia?"**

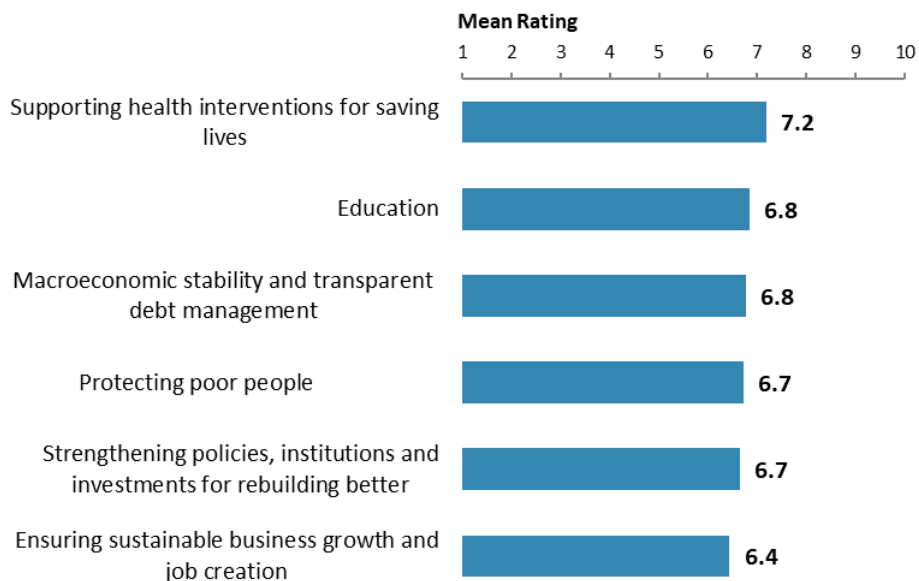

### Support related to COVID-19 outbreak



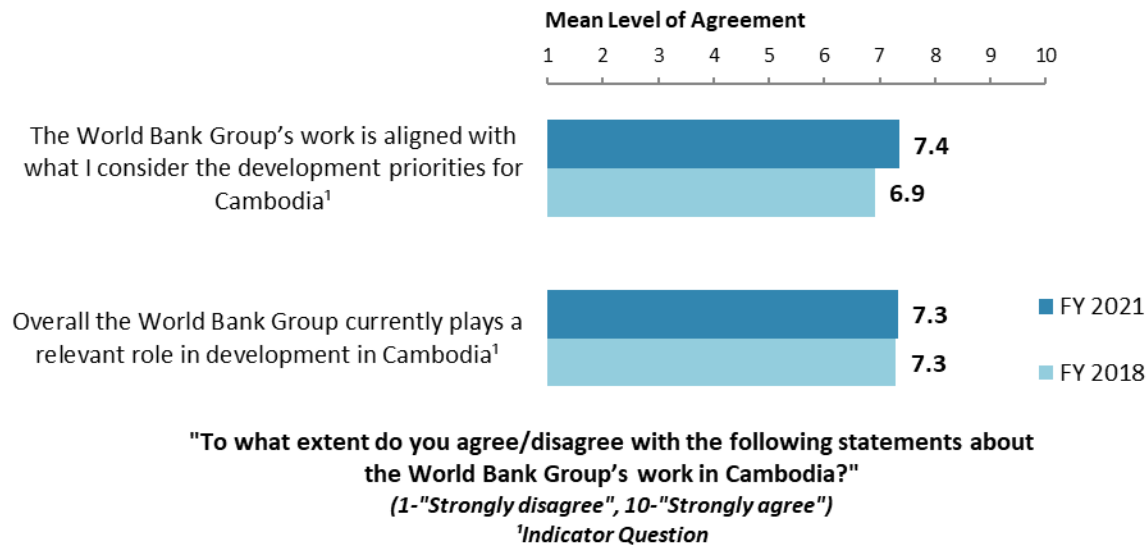

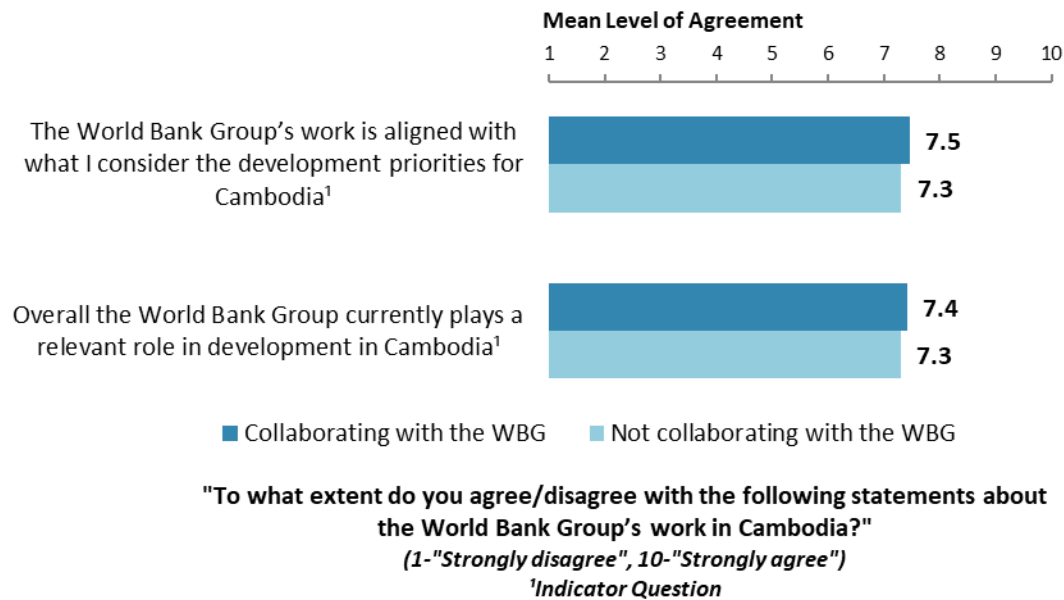

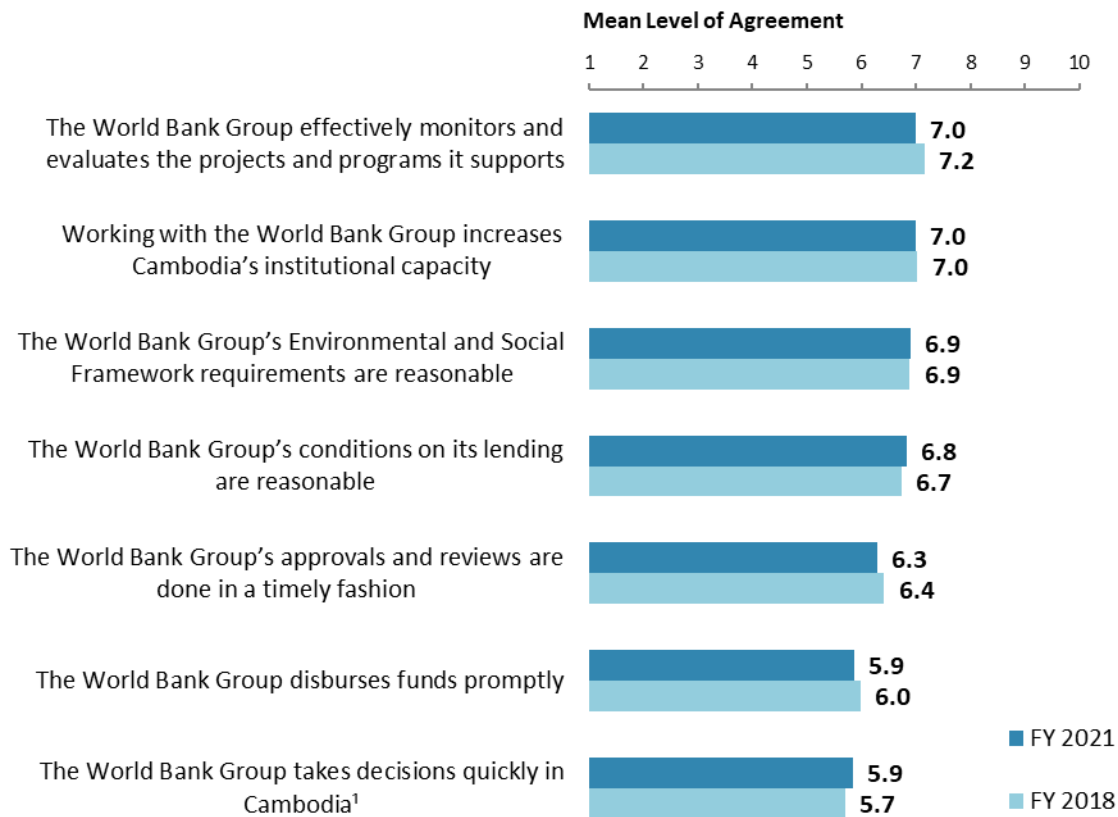

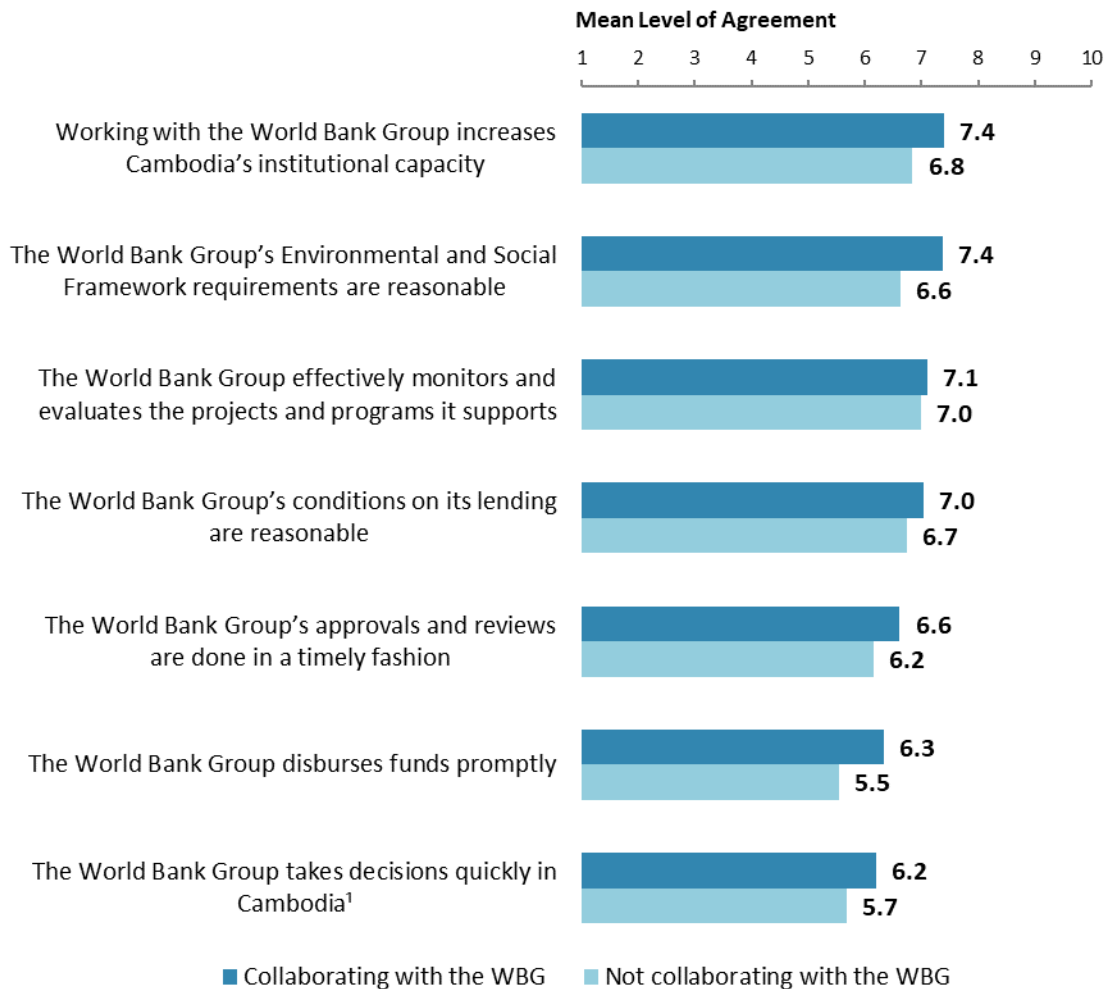

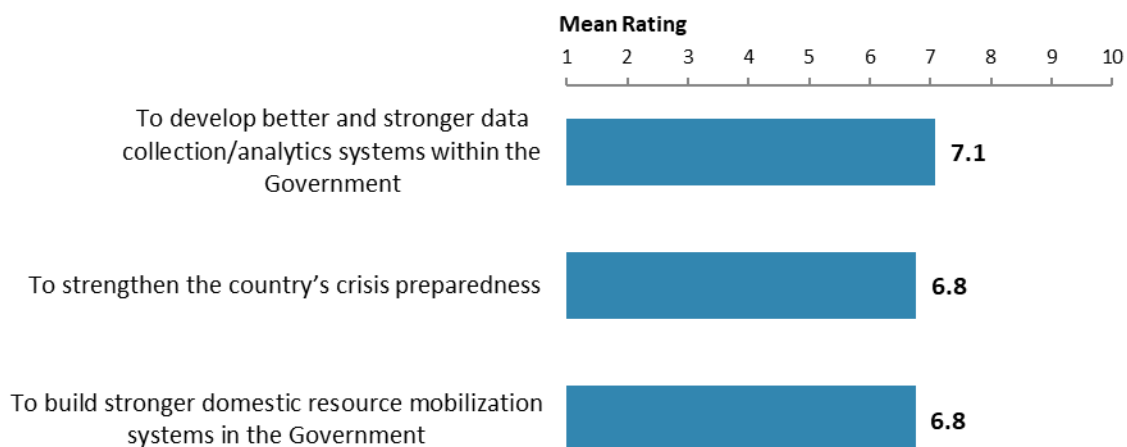

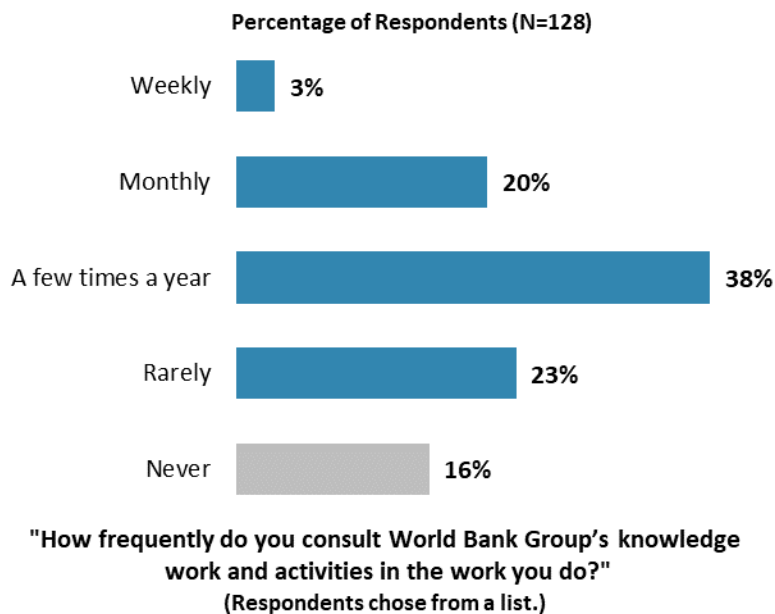


**"How effectively does the World Bank Group support Cambodia's efforts ... ?"**

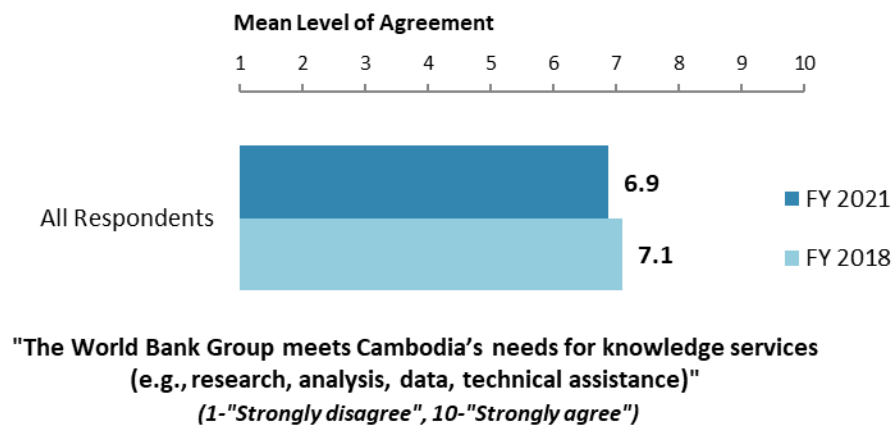

### Meeting Cambodia's Knowledge Needs<sup>14</sup> (Indicator Question)

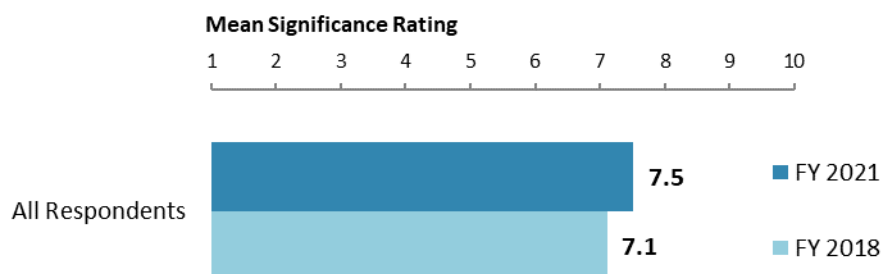

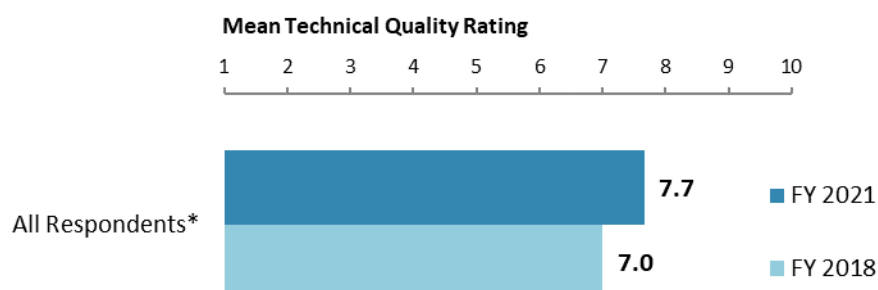

### Technical Quality of the WBG's Knowledge Work and Activities (Indicator Question)



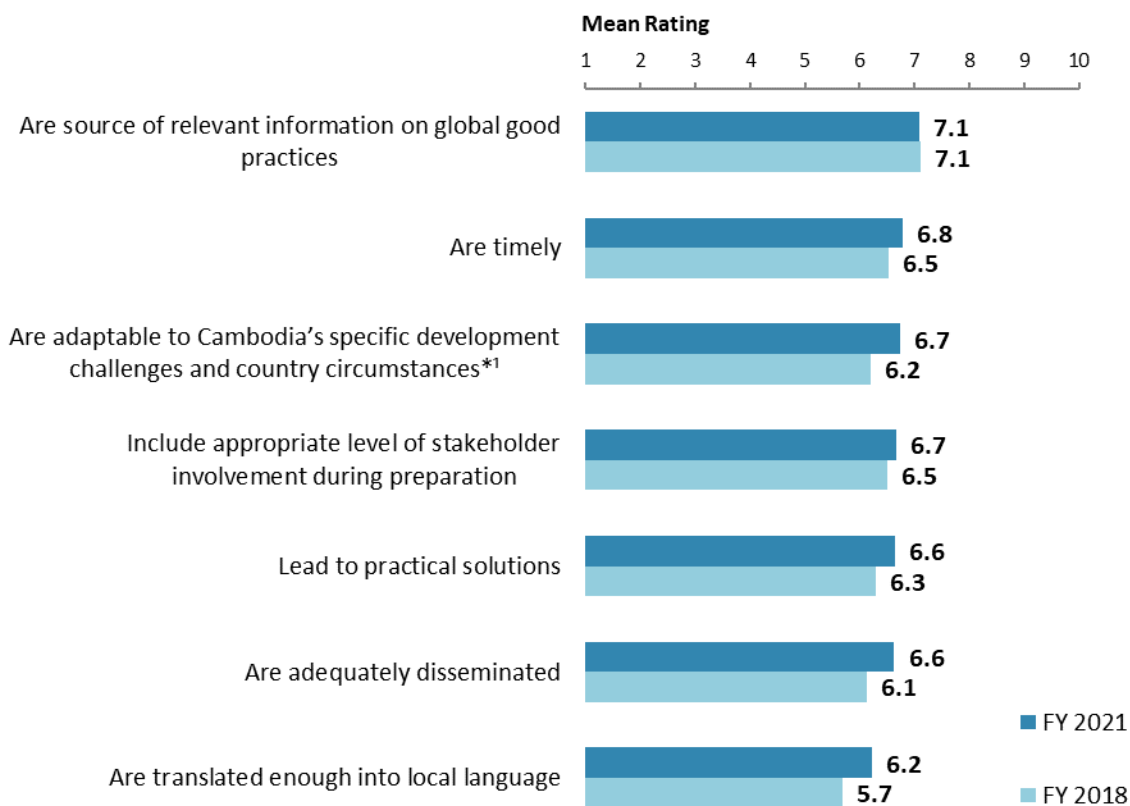

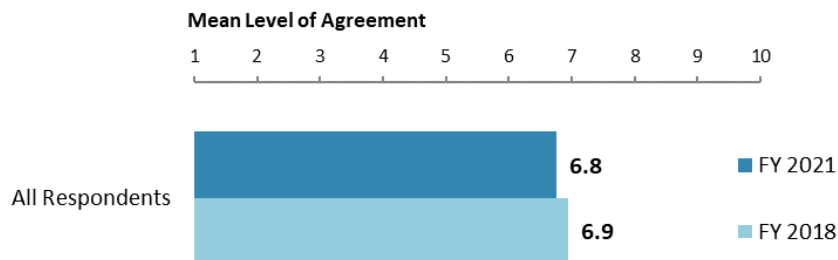

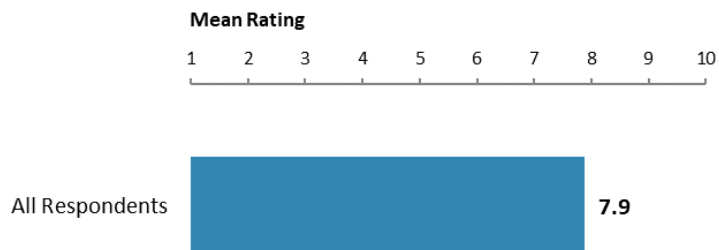

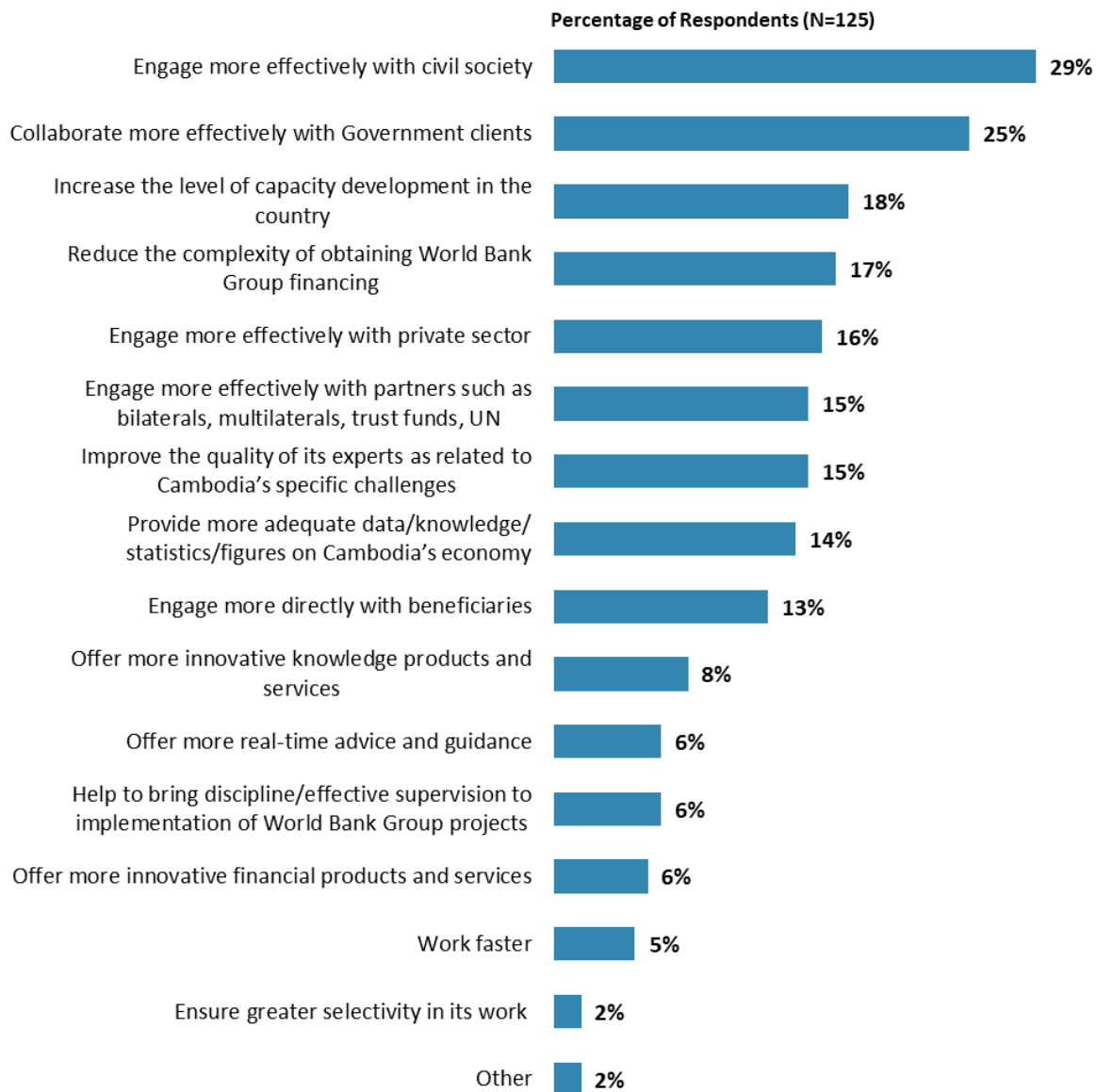

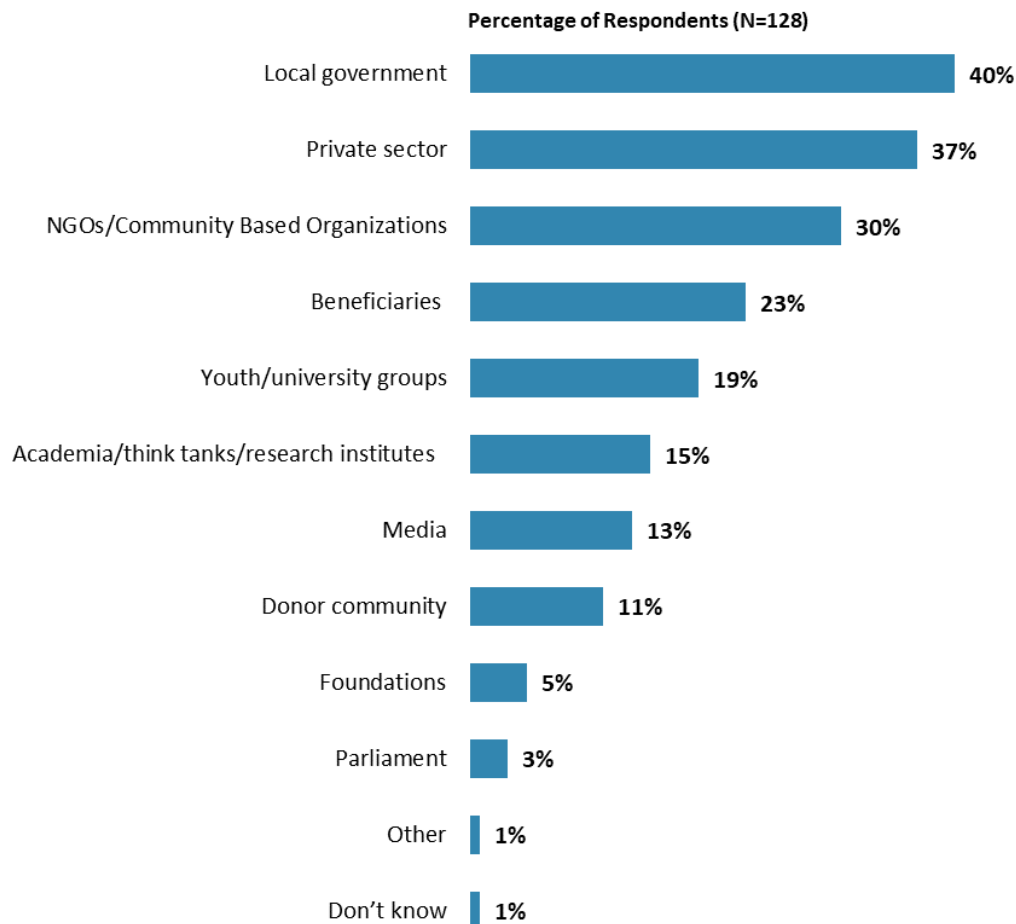
**"Which of the following SHOULD the World Bank Group do to make itself of greater value in Cambodia? (Choose no more than TWO)"**

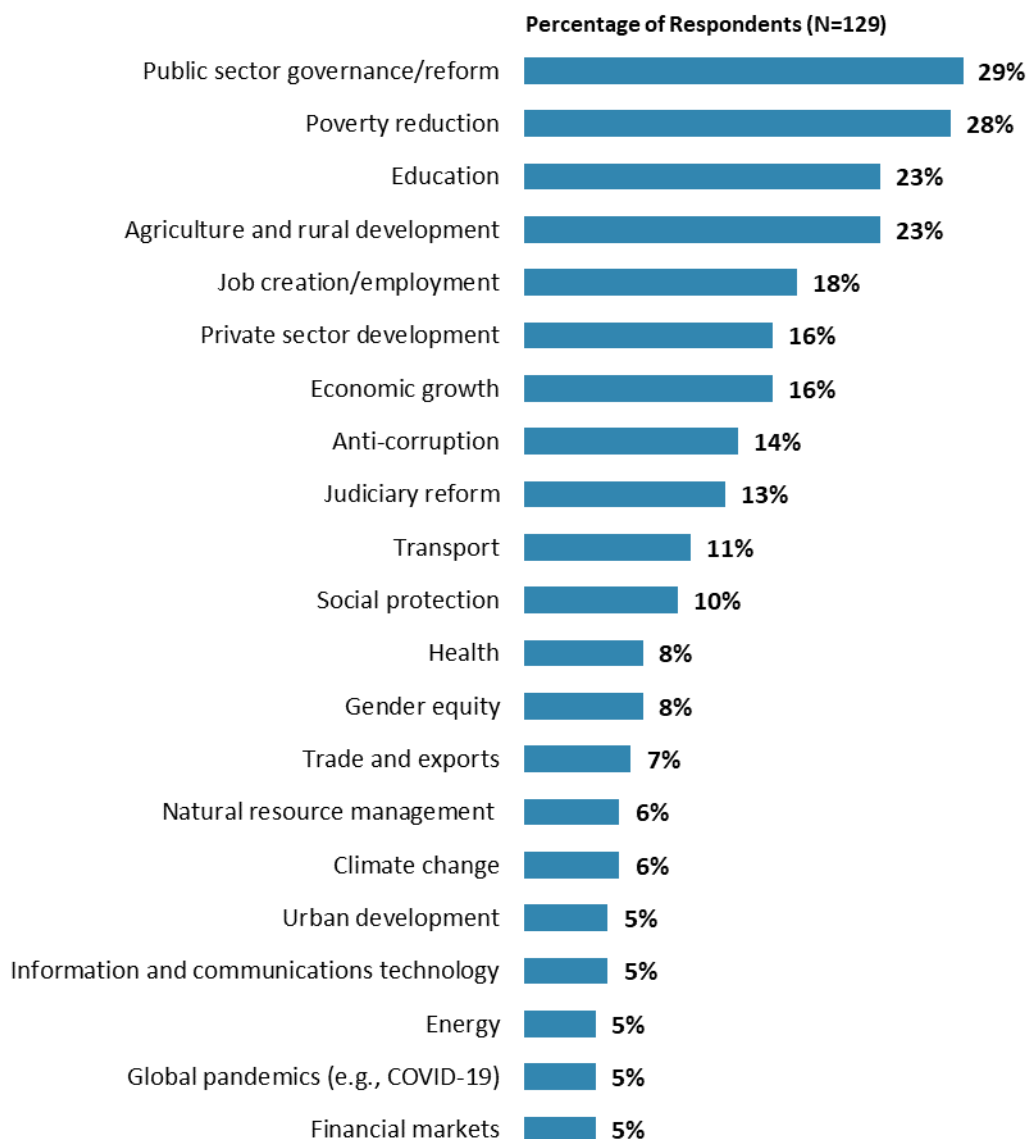
"In addition to the regular relations with the national government, which TWO of the following groups should the World Bank Group collaborate with more in your country? (Choose no more than TWO)"

## IX. The Future Role of the WBG in Cambodia (continued)

- **Year comparison:** Respondents in the previous FY'18 Country Survey indicated that the WBG should focus its resources on “*public sector governance/reform*” (39%), “*education*” (36%), “*job creation/employment*” (22%), “*agriculture modernization and rural development*” (22%), “*skills development*” (19%), and “*private sector development*” (18%). “*Poverty reduction*” emerged among the top areas of the WBG focus, with increase from 15% in FY'18 to 28% in FY'21.

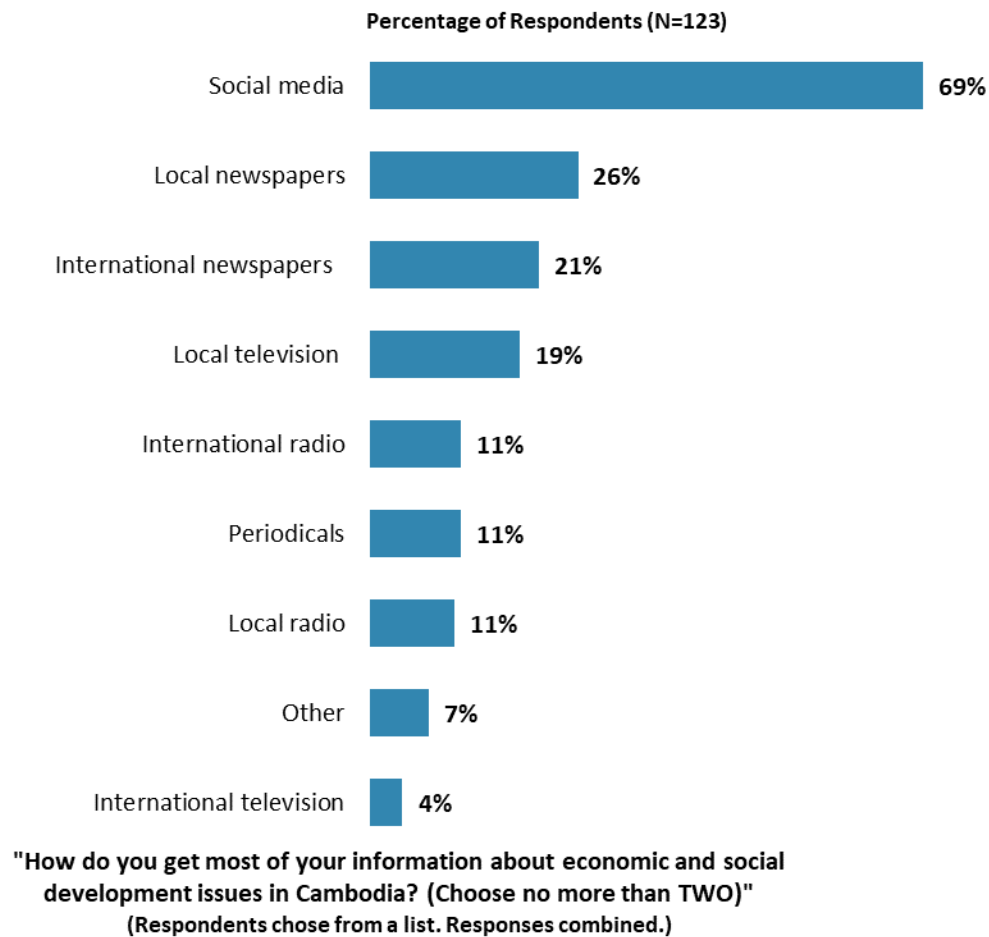

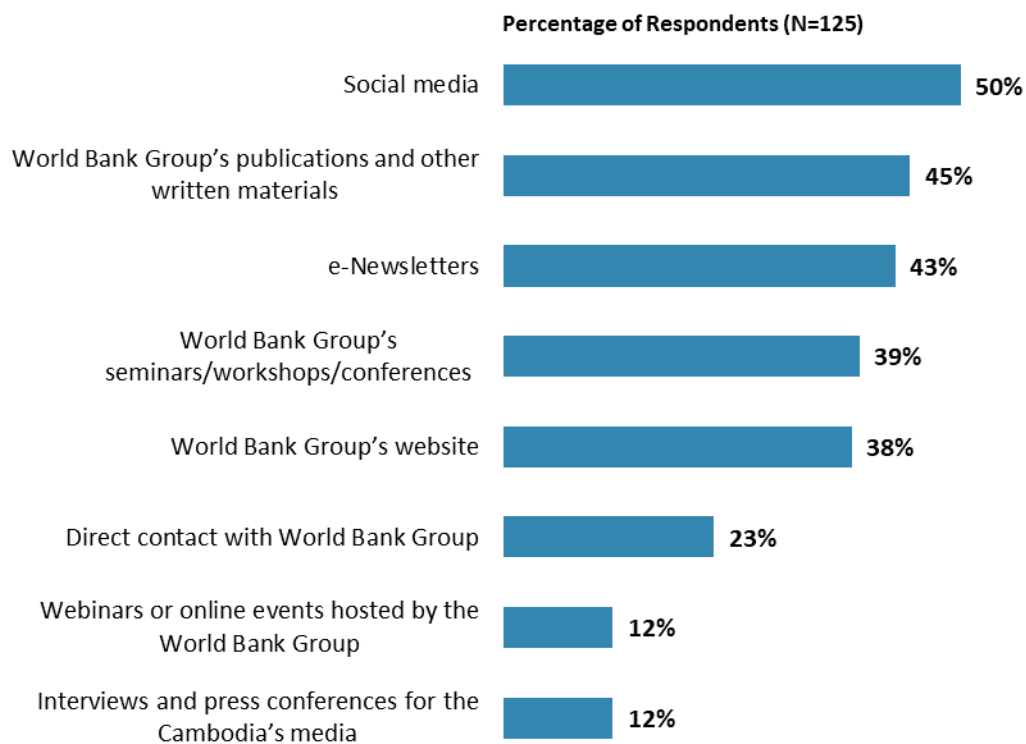

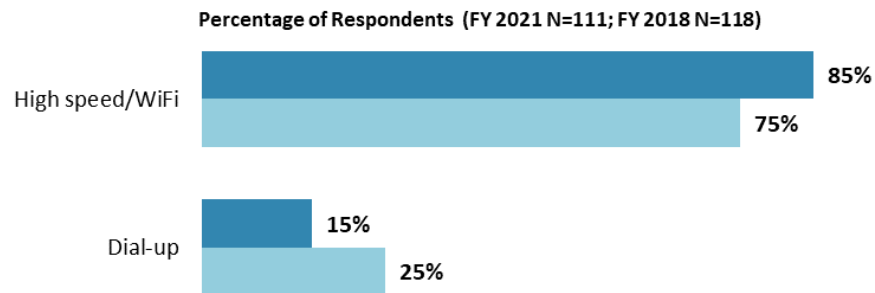


**"How would you prefer to receive information from the World Bank Group?

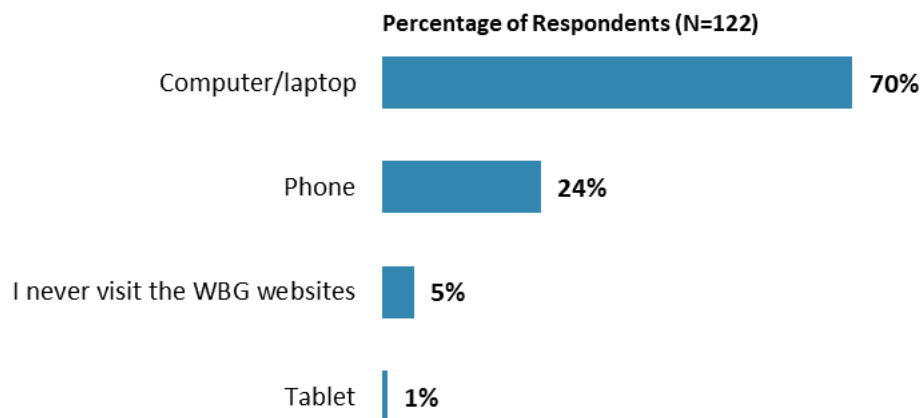
### Internet connection<sup>18</sup>

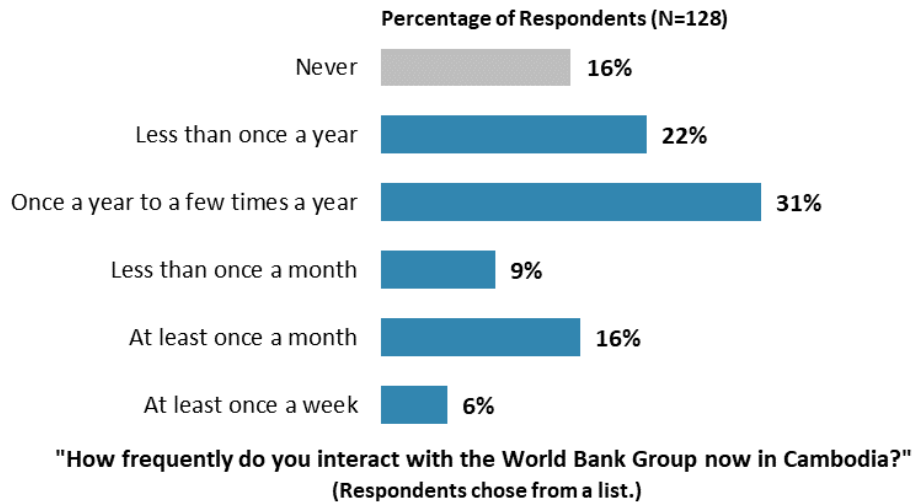

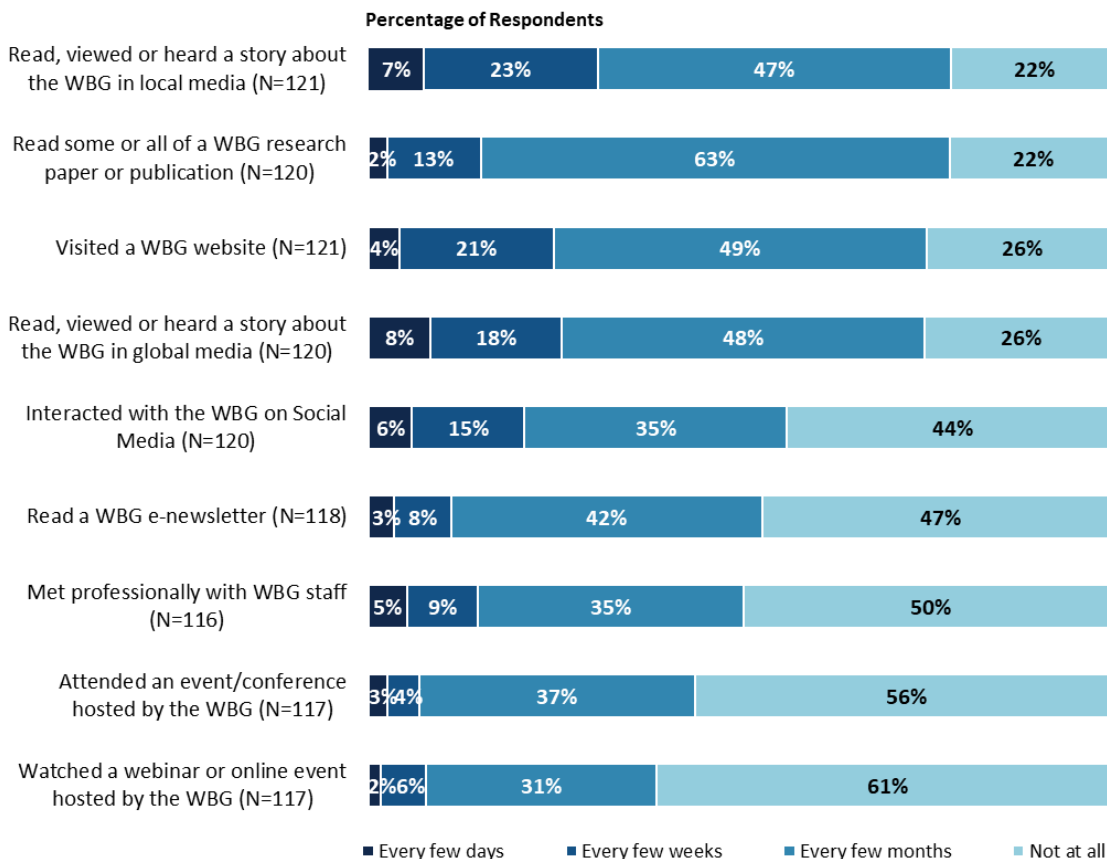
