ABSTRACT
UNHCR continuously collects data on incidents for protection monitoring in the Central African Republic as the lead in the protection cluster. This dataset contains incidents reported on victims in the 5 prefectures of Haute-Kotto, Kemo, Nana-Gribizi, Ouaka and Ouham in the Central African Republic between October and December 2022. Protection incidents were continuously collected throughout the year by UNHCR partners INTERSOS, leveraging their network of community relay and protection committees across the 5 prefectures. A total of 2296 incidents allegedly perpetrated on individuals between October and December 2022 are recorded in this dataset.
