In Gbarpolu we did the total of five Clusters, Cluster 035, EA 049, Cluster 039, EA 018, Cluster 034 EA 048, and Cluster 042, EA 035 all in Gbarma District, and Cluster30, EA 013 in Bopolu District, we worked there for two weeks and then back to Monrovia.
